McClellan Family Chiropractic applies chiropractic adjustments as part of its services. These methods target spinal alignment in the cervical region. Evaluations help determine appropriate approaches for individual patients. The clinic also incorporates principles from The 100 Year Lifestyle, which addresses daily habits related to long-term health.
